3. Relief of the GDSs may be done by the Divisional Heads after confirming that no disciplinary case/vigilance case is pending /contemplated against the GDS.
4. Before giving effect to the above transfer, the SSPOs/SPOs is requested to obtain a written declaration agreeing to the above conditions from the officials in duplicate and keep in the office records.
